

1969 Camaro Giveaway Rules

Sponsor

1. The sponsor is Knoepfler Chevrolet Co.

Who Can Enter

1. To be eligible to participate in this contest, entrant must be an Iowa, Nebraska or South Dakota resident residing within a 200 mile radius of Sioux City, Iowa, must be a United States citizen at least 18 years of age and must hold a valid Iowa, Nebraska or South Dakota driver's license.
